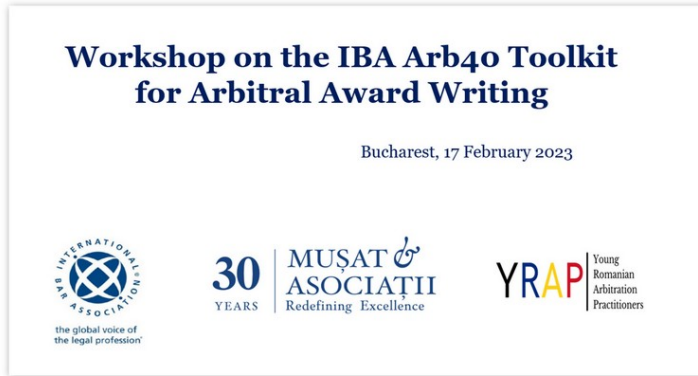


Muşat & Asociații will host on 17 February 2023 the International Bar Association's Workshop on the IBA Arb40 Toolkit for Arbitral Award Writing
