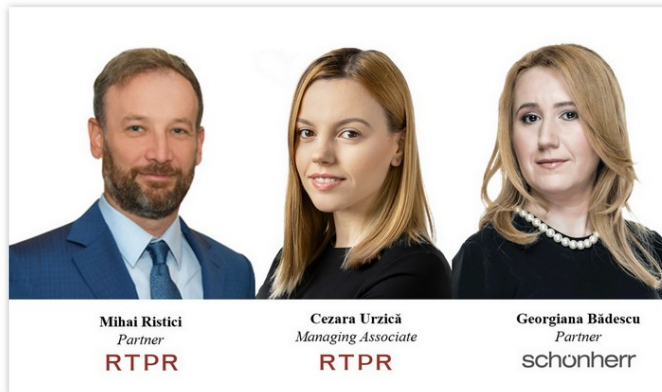


## RTPR advises Romcim on the acquisition of Bauelemente, with Schoenherr advising on merger clearance and FDI
