## Țuca Zbârcea & Asociații has welcomed 100 lawyers from 33 countries to Bucharest



These days, Romania's capital hosted the most important annual event of lawyers in Europe, the Middle East and Asia – Multilaw EMEA Regional Conference. On the sidelines of the congress, the NextGen Lawyers Summit also took place, both events being organised by Multilaw, an international network of independent law firms.
